President Jeffries announced that the Board met in Closed Session and no decisions were made; direction was given to the General Manager and District Counsel.

D. PUBLIC COMMENTS

Kelli Hutten – addressed the Board about a safety concern with the ML Community Park where the drop off is she requested that area to be boarded off for children's safety. Ms. Hutten also suggested that the Harbor consider putting more 20 Minute parking spaces on the backside by the park area so that those that plan to stay less than an hour will not have to pay for parking if there are no other designated places to park. She also said that although the Harbor cannot control what the visitors do when walking to and from the Harbor on the public street the bushes by the KOA Should be cut back to allow for a better street view for cars and pedestrians. Marilyn Vierra said that Monterey County District 2 is working on an application for a Eucalyptus pilot concept. This pilot is specific to North Monterey County for dangerous eucalyptus tree removal only. The county will subsidize 50% of the removal and the other half the homeowners etc. are expected to pay. To get more information they can access the County website. Marilyn also stated that VISTRA now has 24/7 private security and cameras due to base jumpers and thrill seekers. Mark Tuffs addressed the board about a potential tripping hazard where the new docks were placed at the end of B-dock due to new electrical.






Operating Expenses Year to Date Actuals vs. Budget and Prior Year June 30, 2024

ITEM NUMBER 03 – PROJECT STATUS BOARD MEETING JULY 31, 2024

- 1. North Harbor Building: The project was awarded to Dilbeck & Sons Inc. and the project has been underway for the last 4 months. Unfortunately, we experienced a few weeks of delay waiting on Monterey County to approve the added drains to the potential kitchen area that were not included in the original plan. The concrete pad of the building was completed earlier this month. Currently our contractor is working on framing of the staircase and elevator pit and is also in the process of completing plumbing work for the downstairs restrooms. Staff anticipates that the project will be completed in late September or October of 2024. As construction proceeds the General Manager will provide monthly updates to the Board via this staff report.
- 2. <u>North Harbor Inn Project</u>: This project remains on hold while the District explores options with the property.
- 3. <u>Harbor Infrastructure Improvement Project:</u> Resulting from the tsunami that took place on January 15, 2022, staff discovered that the District has sustained damage to piles, docks, shoreline and navigation channels in the Harbor. The Districts consultant, Sea Engineering, is currently working with the multiple permitting agencies to obtain the required permits which we expect to be issued in August 2024. Once permits have been issued staff will put the project out to public bid, secure a contractor, and begin the infrastructure improvement project. The Staff goal is to have the project completed before the end of 2024.
- **4.** Harbor Maintenance Dredging and FEMA Project: Staff received word from the Army Corps of Engineers that they were unable to secure the required permits to complete dredging of the Federal Channel this year and that the project will now take place in 2025. Unfortunately the Harbor District Maintenance Dredging Project will also be delayed until 2025 so that it can be completed in conjunction with the dredging of the Federal Channel.
